CHECKLIST

MARKET LAMB/COMMERCIAL EWE NOMINATION

I have a market lamb or commercial ewe to nominate, what do I need to turn in?

- Completed Household Declaration Form** (www.YouthLivestock.KSU.edu). Double check that no field has been left blank or incomplete. If you have marked “No” for the housing question in Section 1, you must complete Section 2, including listing the species and how you will care for projects not located at your primary residence.
- Tagged Your Animal** by June 15 with a Kansas 4-H Electronic Identification (EID) tag.
- Completed Market Lamb Nomination form** (www.YouthLivestock.KSU.edu). Double check that no field has been left blank or incomplete. This includes contact information, signatures, 4-H tag numbers, breeds, and full scrapie tag number (Flock ID/Premise ID and individual animal number). Scrapie Tag # Example: KSS0035 16121. Make sure that 4-H tag numbers on form match DNA envelopes.
- Completed DNA Hair Sample Envelope**, hair must be pulled, not cut. Obtain at least 40 follicles. All family exhibitors and a parent/guardian must sign the front of the DNA envelope.
- \$8.00 per animal** nomination fee. Make checks payable to *Kansas Junior Livestock Show (or KJLS)*.
- All of the above must be completed and postmarked by **June 15**. Certified Mail is HIGHLY encouraged.

Exhibitors who wish to participate in the Kansas State Fair Grand Drive or the Kansas Junior Livestock Show (KJLS) must complete the entry procedure set forth by each respective show.
